1 Attendance was taken, apologies noted & new members were introduced.

The committee was reminded of the club policies & the need to committee members to be aware of them & complying in executing their duties. Overall we are here for all 600+ members & not our individual interests & teams. All committee members to review the policies on the web site & confirm at next meeting that they are happy to comply.

Policy changes can be adopted by the committee & ratified at the next AGM by members.

It was raised that given the club has expanding interests of members beyond football there needs to be a policy to reconcile divergent interests of these constituents.

It was agreed that the summarised version of the club survey results be put on the club website.

3.1 In the absence of the Treasurer, the president presented the financial report. The club's financial situation is that it still has approximately \$20K of debt. This is expected to be repaid in 2019. Our finances continue to be adversely affected by the poor operating result of the canteen in 2018. Our income is seasonal & no major expenditure can occur until we start to receive 2019 rego's. The level of Hangar Hire income has improved & represents a good source of secondary income.

A recent purge of our out of date canteen inventory will likely add to our 2018 canteen losses.

3.2 The SSFA affiliation documentation has been completed The Office Of Fair Trading annual return has been completed Need to update public officer

The committee considered & adopted a resolution to remove Pat Huolohan as a nominated signatory on the club's bank accounts & for new secretary, Mike Elliott to be added as a nominated signatory on the club's bank accounts.

Mike Elliott was also approved by the committee to hold a club debit card and cards previously issued to Pat Huolohan and Rainy Blake will be cancelled

- 3.4 Mick McGovern has been contracted by the club to act as technical director for U12-U21. This represents one of our more significant financial commitments for the year.

U15's undergoing early season grading to test the ability of forming a A's & B's.

Working on trails for the weekend before the season – details to be confirmed

A 2nd U16 & AL11 team from another 2 clubs is a possibility. The president to notify other club presidents if likely.

Coaches for teams has not been settled

3.5 WU21's teams to be merged into 1 team likely to play as SWD's Extra W18 team not likely to happen
Last year's W16 likely to be a new W18 (totalling 2xW18)

W30 may get 5 players from another club which may provide the possibility of a 3rd team

6 a side comp to start in 2 weeks. 5 teams registered. Ideally would have 6. Referees from the club's accredited junior members is underway.

A standard communication platform for all teams is preferred. At this point Teamer is the preferred platform. This will assist families with multiple family members playing for the club. Managers to be notified. Women's Committee is looking to better align teams with ideas such as combined fitness training & developmental players to train with A Grade on a roster system

Women's mid-season social function to be planned. Leader to be identified. Expected to be a Friday arvo/evening
